See paragraph 7, Decree 6904. Anderson Swale and Wildcat Creek water rights are not included in watermaster billing.				
6/	Tracts 42, 43, 47, 53, 54, and 57 divert water from Clover Creek by the Welch-Nailor Ditch and convey the water to the Welch-Strayer Ditch located within the Oak Run Creek Basin. The decreed irrigated acres from the Welch-Nailor Ditch are not the same as from the Welch-Strayer Ditch, but can be located within the same DWR Tract as the Welch-Strayer irrigated acres. See Oak Run and Clover Creek Decree Maps.				
7/	These are undecreed riparian water rights from Clover Creek and divert through the Welch-Nailor Ditch. They are recorded in Shasta County Official Records Book 2380, Pages 134 - 160 dated 10/8/87. These rights are included in watermaster billing.
